Appointment Letter

Columbus Refinery T&T Limited (“CRTT”) designates **SNT International Logistics LLC**, a duly organized and existing entity with its registered address at **13009 Kain Palms Court Ste 103, Tampa, Florida 33612** (the “Designated Entity”), represented by Mr. Steve Thomas, effective **19th February 2026**, to act on a non-exclusive basis as an independent commercial introducer for product opportunities sourced through CRTT’s global allocation channels, subject strictly to the limitations set forth herein.

This designation is granted exclusively to the Designated Entity identified above. No other individual, affiliate, subsidiary, related party, successor entity, or alternative vehicle shall have any authority or standing under this appointment.

Mr. Steve Thomas is recognized solely in his capacity as an authorized representative of the Designated Entity for purposes of communication and coordination. This appointment does not extend to him personally, nor does it confer any independent authority outside of his representation of the Designated Entity.

This designation may not be assigned, transferred, novated, substituted, or otherwise delegated to any other entity or person without the prior written consent of CRTT. Any attempted assignment or substitution without such consent shall be null and void.

Nature of CRTT’s Operations

CRTT operates through structured allocation arrangements and strategic commercial partnerships with refineries, producers, and authorized distributors globally.

CRTT:

- Does not operate as a stocking reseller;
- Does not maintain physical inventory;
- Sources product volumes through confirmed allocation channels;
- Engages relevant partners directly in final transaction execution.

For clarity, "Allocation" refers to product volumes that CRTT has confirmed access to through its supplier or refinery partners at the time a proposed transaction is evaluated.

Scope of Authorization

Under this appointment, the Designated Entity is authorized solely to:

- Identify and introduce prospective buyers for products that CRTT confirms are available through its Allocations;
- Facilitate preliminary commercial engagement between such buyers and CRTT;
- Support transaction development at CRTT's direction.

This appointment:

- Is non-exclusive;
- Does not grant territorial or product exclusivity;
- Does not confer any rights over CRTT's existing relationships.

Authority Limitations

The Designated Entity is not authorized to:

- Bind CRTT or any CRTT partner to any agreement or commitment;
- Represent confirmed pricing, availability, specifications, logistics, or procedures without written confirmation from CRTT;
- Issue offers, contracts, or commercial documents on behalf of CRTT;
- Accept or collect funds in CRTT's name;
- Represent itself or its representatives as having authority beyond the scope stated herein.

All final decisions regarding availability, pricing, procedures, partner participation, and transaction approval remain solely with CRTT.

CRTT reserves full discretion to accept or decline any proposed transaction.

Compensation

- Compensation is success-based only.
- For transactions introduced and materially developed by the Designated Entity that result in a successfully executed and funded sale, CRTT will agree in writing to a commission on a transaction-by-transaction basis.

- No commission is payable unless confirmed in writing by CRTT.
- Any agreed commission shall be deemed inclusive of all costs, expenses, and efforts incurred by the Designated Entity in connection with the transaction.
- CRTT bears no responsibility for any operating expenses, marketing costs, travel, advisory fees, or liabilities incurred by the Designated Entity.
- No commission is payable on declined, unexecuted, or unfunded transactions.
- Any commission entitlement shall accrue solely to the Designated Entity and to no other person or entity.

Independent Status

This appointment does not create an employment relationship, partnership, joint venture, or agency with authority to bind CRTT.

The Designated Entity acts solely as an independent commercial introducer.

Term

This appointment:

- Commences on the Effective Date;
- Remains valid for one (1) year and renews automatically unless terminated earlier in writing;
- May be terminated by either party at any time in writing;
- Any extension must be expressly confirmed in writing by CRTT.
